Project Requirements:

- Import data from cloud or domain to program.
- Import Data from Website. (Web scrapping)
- Check if data on cloud or domain already exists.
- If not, export data to cloud or domain with images.
- Creating html file to launch from anywhere. (WAN)
- Recreate an excel sheet, which will access the data from your own domain or cloud, similar to what you currently have.

There are three different stages of coding in this:

- Web-scrapping
- Creating a html file to access.
- Excel VBA file (macro), which will access your custom html file on your cloud or domain.



Note:

Once the data from Property24 has been scrapped and converted, the data will be allocated on the domain in a format that will always be accessible, as long as your domain or cloud stays active.

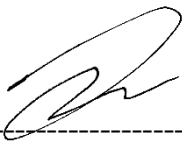
