

Blackhound Architecture & Rendering | Privacy Policy

Protecting your privacy is important to us, and our privacy policy explains exactly how Blackhound Architecture & Rendering (also referred to as “we”, “our” and “us”) uses personal data about our individual users of our website www.blackhoundenterprises.com (the “Website”) and others who access our services through APIs and through third-parties (also referred to as “you”).

1. WHAT TYPE OF PERSONAL DATA DO WE COLLECT?

“Personal data” refers to any information we collect on an identifiable person, i.e. your name, address, contact details, etc, and we obtain this information from our Website, or third party sources such as social media.

The term “process” means any activity relating to personal data, including collection, storage, use and transmission.

We will collect and process different types of personal data from individuals who access our website (“Website Users”) (this might include things like your name, contact details, details about your business, our correspondence with you, records of your transactions with us, and how you use our services) in accordance with data protection laws.

Why? Because we need these details to provide our services to you.

2. HOW WE USE YOUR PERSONAL DATA:

We rely on your consent to process your personal data and we use the data collected to provide our services to you/communicate with you/verify your identity/make sure our website and services are functioning properly/keep accurate records and for legal reasons.

We may also use your personal data to conduct research and analysis to help us understand and improve the use of our website.

3. WHO DO WE SHARE YOUR PERSONAL DATA WITH?

We may use certain trusted third party companies/individuals to help us provide/improve our services (including but not limited to data storage, maintenance services, database management, web analytics, payment processing, and improvement of our services). These third parties will process your personal data on our behalf (as our processor).

In certain circumstances, we will also disclose your personal data to:

3.1 consultants and professional advisors including legal advisors, auditors and accountants;

3.2 business partners and joint ventures;

3.3 insurers;

3.4 courts, court-appointed persons/entities, receivers and liquidators;

3.5 third parties where necessary to comply with a legal obligation, to enforce a contract or to protect the rights, property or safety of our employees, customers or others; and

3.6 to governmental departments or local government.

4. HOW LONG WILL WE KEEP YOUR PERSONAL DATA:

We will only retain your personal data for as long as you are a newsletter subscriber, and if necessary for the purposes for which we are processing it for (including as necessary to comply with our legal or regulatory obligations, resolve disputes, and enforce our agreements).
