1.) PHASE ONE:

- 3d Modelling and Assembly Render:
 - a. 3d modelling:
Blackhound will 3d model the chair.
We will apply the necessary materials and textures to the product so that it can be rendered.
 - b. Assembly Rendering:
We will provide an assembly rendering where we pulled the chair apart indicating all the various elements that go into the chair, as discussed, with the relevant notations on the render.

2.) PHASE TWO:

- 360° Rendering for Website:

We will provide the necessary imagery for the web developers to do an interactive 360 rotation on the website.

By submitting the non-refundable deposit payment or signing this document, you are agreeing to the terms and conditions detailed in this document.

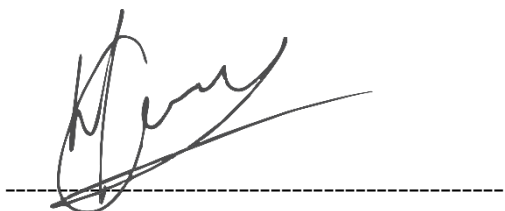
